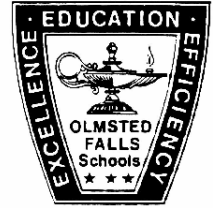

4. I understand that giving false, misleading or fraudulent information under oath is punishable as a criminal offense under the Ohio Revised Code Sections 2921.13 and 2921.21, and is a misdemeanor of the first degree with a maximum fine of \$1,000 and/or maximum jail term of six months.

In the event the Olmsted Falls City School District determines the representations in this document to be false, misleading or fraudulent in that we do not reside in the Olmsted Falls City School District, I understand that I will be responsible and liable for tuition at the rate set by the Treasurer of the Olmsted Falls City School District pursuant to Ohio Revised Code Section 3317.08 and that my child(ren) will immediately be withdrawn from the Olmsted Falls City School District.

6. I understand the Olmsted Falls City School District may use whatever legal means it has at its disposal to verify my residency. I hereby waive all rights to confidentiality of information relative to my residence and give permission to the Olmsted Falls City School District, the City Tax Administrator, and/or the Regional Income Tax Agency (RITA) to release selected information such as name, social security number, current and former address to confirm or deny my residency for the current or prior years.
