Report from the Board of Education Regular Meeting of April 19, 2007.

 - (1) **Mr. Weber** reviewed the financial report for March; discussed the appropriation modifications; and reviewed the purchase order to the Lakewood Board of Education which exceeded 120% of its original obligation.
 - (2) Mr. Lewis/Mrs. Rami Mr. Lewis gave an update on the status of the various current job openings, both teaching and non-teaching, throughout the District Mrs. Rami gave an overview of the Guidance Plan that the Board has been asked to adopt; and reported that the administration of the grade 3-8 achievement tests will be April 30th May 4 with make-up tests the week of May 7-11th; and that results of these tests are due to the District on June 15.
 - (3) Mr. Atkinson reported that: he is finalizing bus specifications for the Ohio Schools Council upcoming bid process; that the new VersaTrans routing software has been completed; that tentative a.m./p.m. kindergarten assignments have been made for the 07-08 SY; as a result of participating in the Energy for Education program (from 1997-2005), the District saved \$192,580.24 in the purchase of electricity; summer grounds projects have been planned; and summer staffing will be recommended at the May Board meeting.
