- B. Administrative Reports
 - (1) **Mr. Hullman** provided the October 31, 2008 financial reports, including an analysis of the 5-year forecast.
 - (2)Mr. Atkinson - Transportation: reported on some recent bus accidents and that our mechanical staff repaired all related damages and the buses are on the road again; reported on the Stearns Road detour (north) beginning November 24 (detour will be Cook to Barton to Lorain) for approximately one year for installation of storm sewer and water lines; also reported that after the new year a sewer extension project will begin on McKenzie Road at the North Olmsted line and proceed south to Cook Road - delays will occur, but traffic will be maintained; Buildings and Grounds: reported that the new wetlands report is due the week of November 17; discussed the very comprehensive maintenance plan that has been required by the Ohio School Facilities Commission and being performed by Four Seasons Environmental, Inc.; the Olmsted Community Baseball League is planning to improve drainage and make other improvements at the Fitch baseball fields; reported that all irrigation lines for the football and soccer fields have been winterized; and reported that Jarod Law inspections will begin Wednesday, November 26; Personnel: interviews for substitute positions for transportation and custodial departments have begun; and our snowplow crew met in late October to further prepare for the upcoming winter season.
 - (3) **Mr. Lewis** informed the Board about the successful staff enrollment in the Section 125 Plan; reviewed and reminded the Board that the funding source of Title I monies will be used to hire tutors at Fitch and the Middle School; also informed the Board that administration is working with OFEA to develop a MOU (Memorandum of Understanding) to clarify Title I tutor contractual rights once funding for their salaries is eliminated; and informed the Board that the out-of-state baseball team trip being asked for approval this evening is fully funded by fundraisers not General Fund monies.
 - (4) **Dr. Lloyd** reported that as a District we continue to make very good progress on the implementation of our CIP at all buildings through the work of the **Building** Leadership Teams working with the **District** Leadership Team; reported on a 2-day workshop for our administrative team to help integrate technology with the classroom walkthrough process (the workshop was funded through the State Personnel Development Grant); and reported on the English-Language Arts materials adoption study.
 - (5) **Dr. Hoadley** shared with the Board of Education a report from the Ohio Board of Regents that displayed College Readiness information for all schools in Cuyahoga County – this report displayed the importance of HS seniors taking a rigorous set of classes in their final year of HS in order to avoid the need to take remedial math and remedial English courses their freshman year of college; shared the results of a recent data analysis of the fifty (50) 9th grade students who had the lowest GPA during the 1st nine week grading period of the 2008-2009 school year – this data analysis showed that 32% of these students are identified as special education

students; 20% of these students qualify for free/reduced lunch; 10% have been suspended at some point during the 1st nine week grading period; and that 14% were new to our District (these 50 students will be closely monitored by the HS administration and the HS counselors; and also reported that he has been selected to be the President of the Olmsted Chamber of Commerce for 2009.
